



**Australian Open 2018 7News Consumer Promotion  
Terms and Conditions**

By entering the **Australian Open 2018 7News Consumer Promotion** (“the Competition”), you are agreeing to the following terms and conditions:

**1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms of entry.

**2. WHO CAN ENTER?**

- 2.1 Subject to clause 2.2, entry is open to all residents over 18 years of age who live in the Melbourne Metropolitan area where the Channel Seven Melbourne (“the Promotor”) signal is received, and who can attend the Australian Open 2018 Tournament on Thursday 25 January 2018 during the day session from 11.30am to 4.00pm AEDT (“Major Prize Event”) and on Tuesday 23 January 2018 from 11.30am to 4.00pm (“Minor Prize Event”)
- 2.2 Employees and their immediate families of Seven Network (Operations) Limited, City of Melbourne and their associated agencies and companies are not eligible to enter.

**3. HOW TO ENTER**

- 3.1 The Competition commences on Sunday 14 January 2018 at 18:00 (AEDT) and concludes on Thursday 18 January 2018 at 23:59 (AEDT) (“the Competition Period”).
- 3.2 In order to enter, viewers must watch Channel 7’s nightly News from 18:00 (AEDT) to 19:00 (AEDT) during the Competition Period, where there will be a Competition segment aired during the period.
- 3.3 To enter the draw, viewers must visit **7News.com.au/MELBWIN** and enter with their name, postal address, contact daytime telephone number (including STD area code), email address and the nightly codeword.

#### 4. **PRIZES**
